Summary: The conference was held and moderated by Romanian Court Of Accounts within the scope of the Romanian Presidency of the Council of the European Union in Bucharest, Romania from 06 to 07 May 2019,

The conference was attended by 53 auditors and experts from 21 SAIs and one Organization (European Court of Auditors, ECA), The main theme of the conference was "Audit Innovations in European Union and Increasing Guiding Roles of the SAIs". In this concept, after introductory messages from Romanian SAI President, The Prime Minister of Romania and The Minister of Public Finance of Romanya, 12 presentations were delivered on such topics as New Approaches to Public Sector Audit in Europe inclining from punishment to advisory role in benefit of citizen, Increasing the Contributions of the SAIs to the Lives of Citizens and Social Impacts of Audit, adopting new ideas in IT Technology such as Digitalisation and Robotization of Audit, Artifical Intelligence, Auditing Big Data,
