

Activity: 13th Meeting of the EUROSAI IT Working Group

Date: 04-05 April 2019

Place: Floriana, Malta

**Summary:** 13th Meeting of the EUROSAI IT Working Group was held in Floriana, Malta, from 4 to 5 April 2019, and hosted by Malta Audit Office.

The main topics discussed and the main issues emphasized are as follows:

E-Government Subgroup

- Call for experts- new experts from interested SAIs into the project (IT and other expertise fields: suppliers, advance suppliers, reviewers, developers)
- Development of the web version of the Active IT Audit Manual to be continued
- Enhancing conformity and looking for synergy: further integration of the CUBE and Internal Control Subcommittee (IC Watch)
- Next CUBE&IT Audit active Manual Workshop on 14-16 October 2019 in Bratislava, Slovakia

Parallel Audit

- Emphasis on planning issues in the parallel audit activity in order to considering the possibility of undertaking parallel audits at an early stage of creating SAIs' work plans
- Focus rather on strategic and emerging topics than on project management system (PA platform)
- The possibility of the using the INTOSAI Collaboration Tool (administered by SAI India)
- Return of completed questionnaires on the planning issues with comments to the questions by the interested SAIs
- An overview in SAI reports on the key topics
- Proposal of key topics based on the overview an questionnaire findings

IT Self-Assessment and IT Audit Self-Assessment

- IT(A)SA continuation of the project is very desirable
- Call for moderators, co-moderators and observers in order to a number of IT(A)SA workshops planned for 2019 and 2020
- Striving to closer cooperation with other INTOSAI regional organisations, especially AFROSAI-E in order to train new moderators, co- moderators and observers as well as perform IT(A)SA workshops

## Strategy

• The results of the workshop on the projects and Group's strategy were gathered. The draft version will be sent to ITWG Members.

## Other Decisions

- Joint comments to Exposure Drafts "Guidance on Audit of Information Systems" an "Guidance on Audit of Security of Information Systems"
- Next meeting will be held in spring 2020 after confirming propositions (Romania or Georgia)
